Ben Stokes, Boyd Valley Cllr. has reported “Unsuitable for Motor Vehicles” signage on Culleysgate lane has been approved to be in place by November. There is no update on the blocked drain by Vine cottage on the junction with Bury Lane and High Street which will continue to be raised by Boyd Valley Cllrs. Stokes and Palmer.</p> <p>The damaged wooden fence on Church end/Doddington Firs/Rosevale by the brook is being chased by Rob Wiltshire at SGC however, as it has been sometime since the clerk has been given an update about this dangerous situation the Clerk will ask for another update and copy in Boyd valley Cllrs.</p> <p>Highways Refreshing of the White lining on Bury Lane at The Cross with the High Street, along with several new faded junctions and Slow signs on the road surfaces around the village, are causing an increasingly dangerous situation to pedestrians and road users.</p> <p>Children from Mill Lane Walk across the River Boyd bridge, onto the High Street, where there is no footpath to The Cross turning to walk along Bury Lane to the Bus stop at the junction with Toghill lane.
